Planning and Transport Committee Meeting

MINUTES of the Planning & Transport Meeting held on Monday 16th October 2023 at Washington Village Hall (Doré Room)

The Meeting was opened by the Chairman at 7:00pm.

PT/10/23/1 To Receive and Approve apologies for absence.

The Committee RESOLVED to ACCEPT apologies from Cllr Heeley.

A report of outstanding actions and matters arising from the last meeting was

circulated (appendix 1).

There was one matter arising about the wall in The Street with the polite 'no parking' notice: Cllr Luckin reported that none of the residents of the nearby properties claimed ownership of the wall. It was noted that the ambulance service would have responsibility for establishing ownership if this was required for a future TRO to

restrict parking for emergency services access.

It was noted that there were no planning applications in the parish for consideration

at the meeting.

PT/09/23/7 Planning Compliance

SDNP/23/00456/OPDEV 2/10/2023 Alleged: construction of outbuilding at Garden Cottage Nursery Highden London Road Washington West Sussex RH20 4BA. Under investigation. The Committee noted this for information.

DISC/23/0186 for the approval of details reserved by Condition 7 to the approved application DC/17/2117 Longbury Hill Wood, Rock Road, Storrington (Washington Parish).

The Senior Planning Compliance Officer confirmed (email to the Council 9th Oct) that the application DISC/23/0186 to discharge Condition 7 was approved and that HDC was "satisfied that the breach of condition notice has now been complied with and therefore EN/20/0362 will now be closed." The Committee RESOLVED to ask for transparency of the decision so that members know the reasons the conditions had been met.

The Clerk reported that she had previously forwarded the decision to the Ward's District Councillors with a request to find out the reasons for the decision. The information was noted.

- PT/10/23/10 Planning & Transport Issues: To Consider the Licences for Speed Indicator
 Devices in Rock Road and London Road for recommendation to Council.

 It was noted that this item was deferred from the FC October meeting pending details of costs for surveying the Rock Road and London Road sites for underground services and future management of the Speed Indicator Devices. A quotation from a traffic management specialist was previously circulated with supporting papers and the WSCC licence agreement for the Council to sign. It was noted that the total cost of the project for both sites, included predicted management costs, would be £13.369.47, which was in excess of the £11,373.97 allocated in the CIL Spending budget. The Assistant Area Highways Manager was yet to respond to the Council's request for information on the traffic regulations which formed part of the agreement. Members agreed that there were serious cost implications to consider because the licence agreement required the Council to indemnify WSCC for any future claims for the devices. It was therefore important to have more clarity on the terms.

Following a discussion was **RESOLVED** that Cllr Lisher, Cllr Luckin and, subject to his agreement, Cllr Heeley, would form a working party to progress the project and make a recommendation to Full Council on 6th November.
