DC/16/1647 Iron Stone Barn, Rock Road, Storrington, RH20 3BQ, Erection of a single storey oak framed extension to rear elevation Discussion was deferred, pending further information to be submitted to the Local Planning Authority. DC/16/1664 Crosswinds, Hampers Lane, Storrington RH20 3HS

Demolition of existing dwelling and construction of 2 x detached 5-bedroom dwellings and associated garaging

After some discussion, Councillors **AGREED** to **OBJECT** on the grounds that the narrow road and proposed dwellings with multiple car parking areas at the end of a narrow drive, would be overdevelopment.

Councillors also felt that the privacy of neighbouring properties should be paramount, should Horsham District Council be mindful to permit the development

DC/16/1730 Corris, Rock Road, Washington, Storrington RH20 3BQ

Demolition of an existing dilapidated stable block and erection of a new single storey log cabin to provide 2x offices and a toilet

Councillors were not cognisant of any application for change of use. However, they viewed the application from the planning perspective, and were concerned with regard to the difficult access onto Rock Road partly obscured by trees and hedging, and a blind summit, to the left. Councillors **AGREED** to **OBJECT** to the application on safety grounds, with regard to the number of vehicle movements that have been stated in the proposal.
