9. Planning and Transport issues

To consider an invitation to respond to a WSCC survey to measure impact of bus stop suspensions along the A24 (Findon-Horsham)

Cllr Heeley informed Councillors that WSCC sought views of passengers and local communities in response to the temporary suspension of all bus stops in selected areas in the County, including the A24 between Findon and Dial Post, for safety reasons. Buses were forced to stop on the inside lane in these locations and A safety review found that given today's traffic conditions, all suspended stops were found to be a road safety risk.

Councillors expressed serious concern for the ongoing loss of bus services and requested that a solution be found as quickly as possible to prevent further isolating vulnerable parishioners.
